- Buy a Dissolution Forms packet from the Court's Family Law Business Office prior to the day of the workshop.
- Be prepared to pay the Court filing fees (or complete an Application for Fee Waiver if eligible).
- Bring the following to the workshop with you:
 - The Dissolution Forms packet (not completed).
 - A black pen.
 - Your last two months' pay stubs and/or a copy of your last tax return.
 - Proof of SSI or CALWORKS (TANF/AFDC) benefits if applicable.
 - If you are unable to write in English, bring an adult person who can write English.
